Jeff explained that the contract is for 30 days but the contractor would be trying to work with the goal in mind of finishing before school starts.

Dan is concerned about whether there are penalties in the contract if the work is not done on time.

Nate asked how the project was being paid for and whether some of those funds could have come from grants. Nate wondered if there were grant options available for such a big safety issue.

Jeff replied that the grant process would have significantly slowed the progress of making the project happen. The timeframe would have been more like 18 months out. In addition, they are not full grants but rather would match our funds. Jeff reiterated that we are using Facility Use Funds from selling Black Oak Campus to make the upgrades necessary to the Twain Harte School Campus now as we agreed that was a good use for the funds.
