2. COMMENTS FROM THE PUBLIC

3. REPORTS

3.1. Superintendent Report

Principal Wingo gave the report on behalf of the Superintendent. He said that Superintendent Hennes wanted Mary Bickley recognized for all of her efforts with LAIR. Superintendent Hennes and Principal Wingo appreciate all she does and her great leadership skills. He said the students had nothing but good things to say about their LAIR trip.

There was a walk-through today for the Gym restrooms. He said that everything seemed to be good. Principal Wingo said that he did not participate in the walk through. Ron Wurz, our Maintenance and Operations Supervisor did participate in the walk through.

The bid for the HVAC replacement is being awarded to Trane U.S. Inc. He said that thirteen HVAC units will be replaced during Thanksgiving break.

Sherry Siewert has been increased 0.5 hours to accommodate the increasing student enrollment in 5th and 6th grade. She will be focusing on writing. There will also be some additional Instructional Aide time for math. He said that a Special Day Kindergarten class has started with Mrs. Gnipp. There are five students enrolled in the class as of today.

Principal Wingo discussed the SBAC results with the board. He said that Twain Harte performed quite well. He said the results were at grade level or above in Math. Similarly, ELA results show the same percentage has met standards or are a little bit below. He said there needs to be a little bit of work in ELA. He said informative writing assessments will be starting this week.

The cafeteria schedule was changed. The 6th, 7th and 8th grade will eat first and 4th and 5th grade levels will eat last.

He also checked with the Fire Department about the service ramp. The Fire Department said that the service ramp needs to be left open during business hours. Ron Wurz will mark and paint the curb and ensure that the area is marked better. He said this will be completed before the weather turns.

He discussed the required Comprehensive Sexual Health Education and HIV Prevention Education. He said that the district will be purchasing the curriculum and it will be implemented in 8th grade with parental consent. He said is does cover all areas including gender expression. Lynn Groff asked if anatomy will be taught prior to 8th grade. Principal Wingo said that it will be touched on in the science curriculum, however the driving force can't be at school. The parents need to teach at home, as well. Principal Wingo said that curriculum is called Positive Prevention. He said he has not approached the staff about who will teach the curriculum, but is planning to.

Member Wingo announced that Kyle Corgiat is the student of the Month for September of 2017.

Kim Star-Knowles said that parent teacher conferences started this week. She said they are enjoying the bench mark writing.

The centers of excellence in K-2 are going great. 1st grade is really progressing in reading. The 7th graders had a very memorable field trip to the Columns of the Giants. Mrs. Ballard and Mrs. Stapp went on a field trip to the Fairgrounds for Farm Day. Everything seems to be going great.

3.5. PATHS Annual Fund Raising Report

Lynn Groff shared that PATHS provided all classrooms with supplies. She said there have been some restraints on their funds; however they will be taking over concession sales. PATHS will be starting an E-script program. In November, there will be a fundraiser and everything will be done online and shipped to homes.

She was very excited to share that PATHS now has their 5013C status.
