3. REPORTS

- 3.1 Superintendent/Principal Reports
 - Every Student Succeeds Award Winner: Dustin Whittle- Superintendent/Principal Wingo and Teacher Mary Bickley presented Dustin with this much deserved award. Mrs. Bickley read the letter submitted for Dustin's nomination detailing all he has overcome to become such a successful student. There will be congratulatory donuts tomorrow morning to celebrate and more congratulations from his peers. Congratulations Dustin, Amazing Job!!!
 - Attendance is stabilizing, we are back to pre-omicron numbers.
 - We are still evaluating the new math curriculum. All grades now have access and are trying it
 out. Once everyone is onboard we will take the next step in the adoption process with plans to
 roll it out for next year.
 - We are also in the very early stage of looking into a possible new middle school ELA adoption.
 - Monthly assemblies are returning starting this month. It's exciting to be able to get back on track with this positive student activity.
 - TK-K registration was today we had a very light turn out, 4TK, 7K. All 11 were siblings of current students. We believe some of the issue is around the pending vaccination legislation.
 - TK age requirement changes are on the horizon, we are watching as these changes develop and are preparing to accommodate younger students here at school.
 - Construction updates: the planned shade structure should go up in July. We are also looking into some possible classroom construction to meet TK requirements.
 - State testing starts in May and Parent Conferences are next week.

3.3 Staff Reports

- Kelly McGraw presented TK-3
 - a) We had a visit from The Cat in the Hat on Dr. Seuss Day, as always a much loved celebrity. There was some fun 100th day events going on and third grade is doing Ninja Math, earning different belt levels for their math achievements.
- Mary Bickley presented 4-8
 - a) 4th Grade is going to Columbia where they will experience the Gold Rush in person, making decisions on how to find gold and where to spend their money.
 - b) 5th Grade is going to Mercer Caverns, and is working hard on the American Revolution.
 - c) 6th Graders are studying Ancient Egypt in both Social Studies and in Language Arts. They've recently written persuasive essays and have some very strong opinions on school uniforms.
 - d) 8th Graders created leprechaun traps with their kindergarten buddies and they will be attending a play at the Gallo Center on May 4th. Also, on May 14th the 8th grade is hosting a car wash to earn money for their Great America graduation trip & Graduation dance.
 - e) Every 6 or 7 weeks Middle school student choose an elective. Current elective choices are Lego Civics, Lego MindStorm, Tie-Dye Art, Cardboard Challenge, Guitar, and Mosaic.
 - f) Our school mosaic is being created during electives, and has largely been created by 6th graders. Because of this, the 6th grade class is hoping to collect enough money to purchase an engraved sponsorship tile.

 - a) Everyone is happy that COVID is winding down and they can get back to their original job responsibilities
- Sports- Basketball is in full swing, 23 kids playing.

4. DISCUSSION/INFORMATION ITEMS

4.1 COVID Update

- Monday March 14, 2022 no more masking requirements, multiple communications have gone out to inform our families of this change. Masks will still be available to students and staff that would like them. Everyone is really looking forward to seeing our students and staffs smiling faces.
- The plans on the consent agenda are updates that contain the masking guideline changes.
- Cases have dropped dramatically; we have had 1 case in the last 4-weeks. Finally, our Librarian can go back to offering services to students as opposed to COVID testing.
- Sports testing is no longer mandatory.
- Vaccination proposals are currently in committee at the state 1) would eliminate all exemptions except medical which aligns with all other vaccinations currently required 2) requires all employees and contractors to have proof of COVID vaccine. We are watching these but we are sure there will be legal challenges if either are passed, we will have to wait and see.
- Hybrid board meeting format is no longer required. We can continue with the format if we would
 like but to date we are not seeing additional participation by the community using the format.
 After discussion the board decided to discontinue the Zoom option for board meetings. It is still
 an option if requested/needed for a special presentation or offsite participant.
- We are still separating lunch tables by class but that is not COVID related it is to help the cafeteria with its reporting requirements. The spacing stickers have been removed and the kids are back to sitting by their friends and enjoying their lunch conversations. Recesses are still by TK-3 and 4-8 grades.

- Teachers can now allow Classroom volunteers at their discretion. We will start communicating this after Spring Break. They will need to be current with any state vaccination/testing requirements.
- The Health Department is expecting a spike in cases after the break. They will be making home testing kits available to anyone who would like to have them available for pre-return testing.
