Her intentions are not to cause any conflict but to plea with the board for the safety of students, her daughter being one. She also stated that she was one of the parents involved with the group that came together over the summer and felt they really got somewhere with the new enforcement with the dress code. However, she feels the universal rules and policy regarding discipline need to be revised and looked over.

Mr. and Mrs. Olsen passed around copies of a letter they prepared and read it aloud for everyone to hear. They are deeply concerned with the discipline policies and procedures, explaining they are worries for the safety of students and faculty.

Mr. Winfield thanked Kathleen Olsen coming here and understands how difficult it was to speak.

The Board was concerned with why they have never been made aware of these issues before and asked that these matters be brought to them sooner and suggested that they receive a monthly report at each board meeting. The Board spoke back and forth and thought it best to continue the conversation in closed session.
