Carol spoke out that before going into a Closed Session the Board is legally required to ask for public comment.

Eli then offered comment to the public.

Carol questioned why the Board was conducting interviews in Closed Session.

Eli replied that it is a standard Board practice to do so. Interviews are not conducted in public.

Carol questioned on what legal basis.

Jeff explained that our legal counsel, Byron Smith, has advised us to conduct the interviews in closed session.

Carol felt that the public had a right to witness what is being said. Carol felt that this way of doing things behind closed doors is archaic. Carol did state that legally the Board can go into closed session to conduct interviews but that she did not agree with it.

Eli stated that in the past the Superintendent interviews have always been conducted in closed session.

Carol argued that the public was present and interested in how the interviews were going to be conducted. Carol felt they have a right to that.

Eli stated again that the Board was advised by legal counsel to go into Closed Session and they would be taking that advice.

Nate wanted to explain that the Board had been open to public comment over the last couple of months. The public had also been involved in an Advisory Committee to the board. The Advisory Committee was formed to work with the Board up to this point. The public has been a part of the process.

Lynn Groff confirmed that she was on the committee and the public was asked for their opinion on individuals that may be interested.

The Public Session was adjourned at 4:08 p.m. and the Board immediately went into Closed Session.
