3.1. Superintendent Report,

Superintendent Hennes reviewed the board policy regarding the use of pepper spray and taser guns on campus. He said there is not any special circumstance where pepper spray or taser guns are ever allowed on campus. There are not any exclusions.

Superintendent Hennes explained that there is going to be a slight delay in the band building construction. There was a glitch regarding the ordering timeline. He said that the current building has lived its life and the Architect said the building needs to be demolished and a whole new foundation needs to be constructed. He said we are exploring our options as to where we might house band to begin the new school year.

Superintendent Hennes said there will be a Special Board Meeting on Wednesday, April 25, 2018 at 4:00 p.m. in the board room to vote on the approval or denial of the Charter Petition. The public is invited to attend.

3.2. Board Member Report-

Member Brady announced the Student of the Month for March 2018 is Brayden Wegner.

3.3. Principal Report

Mr. Wingo said the teachers are preparing the students for state testing. He said he is working with the Tech Department trying to iron out some glitches prior to testing. He said the ALICE training drills start tomorrow. There will be three Deputies here running the drills.

The Site Council is meeting to develop clear procedures for volunteers. He said they will be wrapping up the volunteer procedures at the next meeting.

He said they are talking about implementing all-day kindergarten. Mr. Wingo said the year would begin with half day kindergarten for the first six weeks. Mr. Wingo said that if Twain Harte switches to all day kindergarten, transportation will be less of an issue. Currently there are 21 kindergarten students enrolled for next year, along with 3 transitional kindergarten students.

Lindsey Bannwarth shared that the 3rd-8th grade will be going to Lion King at Summerville High School next week.

The 4th and 5th grade did their Mother's Day Pottery projects today. They made owls. The 6th and 7th grade will be going to SRT to see Mid-Summer Night's Dream in a few weeks.

The 8th and 1st grade buddies utilized the County IMC program dash and dot robots. The 8th grade is getting ready for the parent tea, the Santa Cruz camping trip and planning for graduation.

Teachers are participating in a Step Up Challenge that will last through mid May. We are Competing against all the schools in the County.

State testing starts the first week of May. Our testing theme is Rock that Test. We will be doing a few activities to encourage the students to do their best on the test.

There will be a Rock and Roll Fun Run On April 27, 2018.

Field Day will be June 5, 2018.
