2. COMMENTS FROM THE PUBLIC

Mrs. Lynn Groff spoke about the Food Bank project she has been spearheading for Twain Harte School in partnership with ATCAA. PATHS decided to take the Food Bank over this year. Mrs. Groff said there have been very few issues and everything seems to be running smoothly. She said if anyone has questions, please contact her.

Principal Wingo said that Mrs. Groff has been making sure that plenty of food is being provided to our students. He said that she has done a great job with the program.

3. REPORTS

3.1. Superintendent Report

Superintendent Hennes updated the Board on the remodel project. He said that during the final inspection, there was a flaw in the design of the boy's restroom. It is being repaired and the district will not incur any additional costs. Superintendent Hennes gave the board a tour of the restrooms in the gym. Eli Wingo suggested that some signage be posted in regards to opening the door slowly.

Superintendent Hennes shared that Mrs. Bickley did a great job with the Harvest Breakfast. The Food was great. He said it was a first class operation. He said it was nice to have parents volunteer that are Save Serve certified.

He praised Mrs. Gnipp for doing a great job with our high need students. She has been providing the specialty services that are not being provided by the County anymore.

Charlotte Knox was here last week and helped get staff on target. She met with staff and graded anchor papers. He said there was good discussion and participation.

The HVAC units will be installed during Thanksgiving, weather permitting.

There will be a new architect working on our lighting project.

Superintendent Hennes said he has been researching funding for Twain Harte possibly qualifying for state modernization.

Friday is the end of the first trimester.

3.2. Board Member Reports

Member Hoffman-Brady referred to an article in the paper regarding retirement and liability health insurance coverage and the hardships that other districts are facing. He said he is very proud that Twain Harte School District will not be facing a hardship due to post employment retirement and liability health insurance coverage. He attended a workshop a few years ago that taught districts what to do to prevent a hardship to districts. Twain Harte deposited current and future post-employment retirement benefits into Fund 20 and will not be faced with the hardships that some districts are facing.

Member Wingo announced that Ben Rishel is the Student of the Month for October, 2017.

3.3. Principal Report

Principal Wingo shared that the California School's Dashboard Local Indicator Report for Fall of 2017 was released about a day ago. Priority 1 was met-Appropriately assigned Teachers, Access to curriculum-aligned instructional materials, and safe, clean and functional school facilities (SARC). Priority 2 was met-Self Reflection Tool for Implementation of State Academic Standards (Reflection Tool). Priority 3 was met-Self Reflection Tool for Parent Engagement (Parent Survey). Priority 6 was not met-School Climate (2016 CHKS).

The Dashboard is accessible by the public online and the link is on the school webpage.

3.4. Staff Report

Mrs. DeMars gave the board an update on her new report card system and how she is issuing grades for fourth grade. She explained that she is reporting on the standard and not issuing a letter grade. The students are learning how to differentiate the standard and not the letter grade. She said the tech piece has been a little tricky with SchoolWise, but the report cards are working very well. She said the students are assessing themselves daily and are very excited about it.

Mrs. Ballard shared that third grade is going to SRT to see a White Christmas. She said this is a great opportunity to teach about social etiquette. Some of the students have not had the opportunity to see a play. The students are super excited.

She said her third grade class participated in games with parent's day. She said it was super awesome. She said the attendance was great and it was fun.

Mrs. Olsen said that Mrs. Gnipp has been doing a wonderful job with the students.

Mrs. Olsen and Mrs. Gnipp said the Administration has been amazing. She shared that staff enjoyed meeting with Charlotte Knox. It was very helpful and they gained a lot of information.

Mrs. Olsen said she can't speak for everyone, but feel the staff moral and the climate is good. People are doing things together and getting together more often.

Mrs. DeMars said that Mrs. Siewert is doing a great job in writing.

Mrs. DeMars shared that Mrs. Gnipp ran a 26.2 mile marathon.
