7.1. Administrative Report

Career Achievement and Excellence in Teaching Award/ Larry Gold Dan Mayers stated that yesterday they had the Second Trimester Honor Roll bowl a thon, and there were 84 students present. Tomorrow Tuolumne County Superintendent of School will be hosting an award dinner, and this year we are acknowledging Joan Amaro and Janet Blaum for doing an outstanding job. Dan Mayers informed the Board that he is having a LCAP parent meeting on March 20th. Challenge Day is on April 10th and Dan Mayers would like to have any Board Members come to participate at this conference. Dan Mayers informed the Board that we were nominated by the California Businesses for Educational Excellence, a couple of years ago we were nominated as an Honor Roll school and once again in 2013. We have a banner that we can put up in the cafeteria showing that we were an Honor Roll School. There were only two school nominated in Tuolumne County Belleview and Black Oak. Twain Harte Community Water District has come around and would like us to paint some water barrels to help conserve water. They will place them around the Twain Harte area. Dan Mayers submitted to information to the Board regarding a Board Policy from Columbia School about Search and Seizure. He would like to set up a Board Policy for our school that will allow us to bring in the search and seizure dogs.

Jeff Winfield informed the Board that we are still going forward with combining our schools as of July 1, 2014. We are still looking into getting information on changing our District name. We will be setting up a MOU with Soulsbyville School for a Tech person. Every year each school

chooses a teacher to receive the Excellence in Teaching Award, this year the teaching staff chose Larry Gold, there will be a dinner held at Black Oak Casino if any of the Board Members would like to attend. Dan Mayers stated that the committee has found a program called Engaged New York that is free and fits all the requirements for Common Core, so the committee is considering using Engaged New York for the Common Core Math books.

Wendie Roberts stated the Yearbook has been sent out to be printed. She met with another company but wasn't impressed, and Twain Harte School will continue to use the printing company that they have previously used.

7.2. Student Council Report

Michele Harper gave the Board the information on the Student Council Report. The Mardi Gras dance was a huge success, they gave away a lot of accessories like hats and horns with the first 50 tickets purchased. They sold 50 tickets before the dance and this doesn't normally happen. The 8th grade students took a field trip to Summerville High for a Robotic Club, they learned that there is a Robotic Class that the students learn code. They can design things on computers and print them in 3D. The Honor Roll field trip was fun, they went to Black Oak bowling, then to Eproson Park for pizza and soda.

Kimberlie Ballard stated that the school in the process of getting everything set up in the Common Core for Math. The students are excited about the new way of learning math. Dan Mayers informed the Board that he attend a Math Adoption at the County and they are trying to find a program that they all agree on.

Ronda Bailey informed the Board what the two figures meant concerning the amount of the appraisal for Black Oak School. The sale comparison appraisal is \$1.19 million and the income appraisal is \$1.15 million. This means that the income is based on if the property was producing income and since it isn't producing income it would be considered less value.

Byron Smith stated that this will begin a process with multi-steps for the Board to follow towards selling Black Oak School. The first step was a 7-11Advisory Committee formed for Black Oak School. The Advisory Committee recommended that Black Oak be sold. Byron Smith stated that

the District sent out a letter to Charter schools to give them the first choice on purchasing Black Oak School. None of the Charter Schools wanted to purchase the school. The District office will send out letter to the Public Agencies letting them know that the school will be available for them to purchase, Public Agencies will have 60 days from the time letters are sent out to let the District know in writing if they want to purchase the school.
