2. COMMENTS FROM THE PUBLIC

Marsha Williams from ATCA Head Start spoke to the board and the audience about Head Start in Tuolumne County. She said they sent 51 student to kindergarten this year. She said they serve Approximately 100 students. Head Start operates 175 days, 6.0 hours per day. They assist with making sure that students are school ready. A copy of the Head Start Annual Report was handed out to the board members.

Superintendent Hennes and Principal Wingo met with the THFT last week for the first time to discuss negotiations. The discussion are were cordial, and this meeting mainly was about each side explaining their requests. Another meeting is being scheduled in a few weeks.

There was not enough paint to complete the concrete stairs. Paint was ordered and delivered today.

Principal Wingo said that the last day of conferences is tomorrow.

Girls Basketball is also wrapping up. They played their last home game on Tuesday. The test scores were released, and Principal Wingo will go over the results, at the next board meeting.

3.4. Staff Reports

Ms. Berry and Mrs. Ballard presented the staff report.

They shared that Mrs. DeMar's class will be having a Forest Service Ranger visiting on October 15th to issue 4th grade The Every Kid in the Park pass. These passes are issued to all 4th grade students across the nation. This allows 4th grade students and their families to gain access to many national and state parks for free for a year.

Mrs. DeMars' class has a 4th grade field trip schedule for November 8th to New Melones Visitor Center. A ranger will also be coming prior to the trip to educate the class about water conservation.

The 4th grade is on week 2 of the Global Read Aloud and are enjoying the book, Amal Unbound. They have participated in a Mystery Skype with a school in Iowa. They are working hard to make global connections.

Mrs. Ballard said that week was Fire Prevention week. The Fire Department was on campus to Discuss fire safety and they were also available for pictures with the students.

Mrs. Ballard shared that her class went on a field trip to the fairgrounds last week for Farm Day. She said a speaker spoke to the class about Bees.

The 3rd graders also painted rocks for the garden.

Mrs. Ballard also hosted Games with Grown Ups afternoon in her classroom with her students and their parents.

Lastly, the class has started writing letter to their pen pals at Curtis Creek School.

Ms. Berry's class will be working with Gini Siebert, formerly of Out of Hand Clay, to make pottery ornaments beginning in November. Mrs. Bickley's class will be working with her as well.

Mrs. Bickley's 5th grade class is on week 2 of the Global Read Aloud, and her students love Amal Unbound. Her class is enjoying using www.socrative.com for testing and academic discussion, as well as becoming speedy typists on www.typingclub.com.

Mrs. Bickley and Mrs. DeMars recently attended the Salmonids in the Classroom workshop held

at the County Office to learn about, and earn a permit to raise salmon. The County has loaned the 5^{th} graders the necessary equipment.
