- 3.1 Superintendent Report
- Permission was granted by the County Health Department to conduct in person board meetings with COVID-19 protocols in place.
- Day 3 of all students back on campus is going very well. Thank you to Principal Wingo, our Teachers and our Support Staff. They have done an exceptional job getting us prepared to bring our students back.
- Parents have been very supportive of the re-opening. We do have a few that are keeping their students on home study due to specific health concerns. Two are home hospital, 1 is the sibling in one of the home hospital homes.
- We will be conducting board interviews for our two open seats on October 27th.
- We have been awarded a School Bus Grant to purchase a much needed new bus. Thank you to Tonya Royce for making this happen. The grant is funded through a facilities grant offered by the USDA.
- No Halloween Parade this year. We regret that this will not be permitted due to the COVID-19 restrictions in place for the county.
- 3.2 Principal Report
- Yes, to the Halloween Carnival, COVID-Style. While we cannot have the parade thanks to Mrs. Rose and the 8th grade class we will have a carnival! COVID Protocols will be in place: outside events only, one class at a time, disinfecting between each class and masks.
- Parent conferences have been pushed back to November.
- The full re-open has been going very well. The entire team is doing an amazing job working with crazy lunch, recess and pickup/drop off schedules.
- Thank you to Twain Harte Bible for letting us borrow additional tables and desks. We would not have been able to open without them.
- We have two long term substitutes on staff: Denise Cablayan to help with upper grade math and Scott Deihl for our 4th grade class.

- The Arts: Ms. Steans will be back on campus Fridays for upper grade Art instruction. Charis Hernandez will be offering art to our primary grades. Music is still a challenge but our Music Director Summer Appling is still offering Zoom instruction/music lessons and will be offering in person music theory to our 6-8 grade.
- Absences are about the same as during the hybrid schedule. The attendance tracking for hybrid was extremely difficult now that we are back on campus the attendance reporting is back to normal.
- Entrance temperature taking points are going well. We have not had an issue with parents bringing sick students to school. Mask wearing is also going well with students. There have been some gentle reminders but students are adhering to the protocol. Teachers are also adhering to the mask/shield protocol and have been supplied with any PPE they have requested to keep everyone a safe as possible at school.
- Technology purchases: Beyond the student devices, we have installed a new screen in the gym to be used for presentations and graduation in the future. New Cleartouch boards have been purchased for all classrooms allowing our Teachers the support they need to deliver instruction in a more interactive digital environment.
- Our emotional support team is available and working with students as they face the emotional challenges caused by the pandemic and other life issues.
- Bus routes are currently being evaluated in preparation for colder weather and maintaining appropriate distancing on the bus.
