While developing the ESSER III plan, Twain Harte School District(LEA) sought input from parents through the use of a survey. The survey was available between September 8 and September 17, 2021. The district received 49 responses to the survey. Input was sought from classified and certificated staff members at staff meetings held on September 1 and September 15, 2021. The LEA also sought input from individuals or agencies representing the interests of Tribal Youth, Homeless and Foster Youth, youth who are low-income, youth who are incarcerated, students with disabilities, students of color, and students who are English Learners. Input was also received from community organizations and partners such as the Yes Partnership and ATCAA, the Amador-Tuolumne Community Action Agency. This outreach occurred during the time period of September 8-September 17, 2021. A survey for written responses was created and distributed during a meeting of the Student Attendance Review Board Members, which represent a number of agencies working with youth in the community, and with follow up emails as well as direct outreach to other community agencies and representatives through email and phone calls. The Twain Harte School District evaluated its stakeholder engagement opportunities and determined that Civil Rights Groups/ Migratory Students are neither present nor served by the LEA.

A description of how the development of the plan was influenced by community input.

The development of the plan was influenced by input received from students, families, school personnel, community organizations and representatives of student groups identified above in the following ways. Stakeholder groups identified the following areas as areas of concern: increased social/emotional and mental health support and continued academic support for all students.

Our plan was influenced by this community input in the following ways:

Continuing the use of a second math teacher in the middle school grades (6-8) to allow for more targeted math instruction.

Addition of an intervention teacher to address the loss of learning.

Additional hours for our student support specialist to provide social emotional support to students.

Addition of a school psychologist to address the increased mental health needs of our students and provide instructional support to staff when working with students with mental health needs.

ESSER III Expenditure Plan Instructions

Introduction

 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.
