Member Anderson: Do you enough testing supplies and how long for test results?

Superintendent Wingo: We have a good supply of PCR tests but it is taking 5-7 days to get results. We currently have a good supply of the Binex Rapid tests but we are going through them quickly. We will be testing 60+ students Tuesday. We are trying to be optimistic and hope this variant will move through quickly so we can get back to regular operations.

- Superintendents letter and CDPH Response letter- The Superintendents did receive a form letter response from the Governor's office thanking them for their letter and reiterated their stance on the vaccine and masks.
