3. REPORTS

- 3.1 Superintendent/Principal Reports:
- The sunshade structure is still in process; delays are being caused by the weather. They are scheduled to be back out tomorrow and Friday to wrap things up while if the weather cooperates.
- The new roof is being tested with all this weather and is doing great. Maintenance is staying on top of any potential issues, clearing drains, covering AC units, etc.
- We are working with Schrader and Associates to evaluate potential state funding availability for TK/K classroom modernization. They have determined we may have access to \$750k with a \$250k match commitment from THSD to update our TK facilities.
- Attendance this week is at 91.43%, last year was 89.16 we are up 2.27%. This number includes the week before the holiday break when we had between 67-72 students out ill. Currently 7 out of 10 grades are above 90% attendance, last year there were only 3 grades above 90%. This is one of our main focus points for this year and we are definitely moving in the right direction. We continue to have conferences with parents of students with high absences and are making home visits to any chronic absentee problems. We are going through the SARB process in appropriate cases.
- State testing is in May. Teachers will start preparing students for testing in upcoming months. The new Illustrative Math curriculum and Building Fact Fluency program that Ms. Cablayan is coordinating for the school are being very well received by both teachers and students.
- ELOP after school funding is available to offer extra support to disadvantaged youth. Currently we just have PM club as part of this program. We are brainstorming some ideas to expand after school support. In February we are kicking off an afterschool tutoring program which we are calling "T.E.C." time, Tutoring, Enrichment, Counseling, we are building a schedule around teacher availability and type of support they will be offering.

Karrie Curry, Cafeteria Coordinator introduced herself to the board, she is very happy to be onboard and part of the Twain Harte team.

Both our breakfast and lunch meal counts are growing

- We now have 7th and 8th grade helpers in the kitchen. It has been a great help to us and a great opportunity for our students.
- We are now a peanut free kitchen.
- Our new oven is in and working. We can now serve hot food even if the power is out.
- We are ordering two additional pieces of equipment to make our kitchen more efficient for our students and staff. We are adding a milk cooler and a warming oven, both will allow for safer more cost effective storage of meals.
